FUNCTIONAL ELIGIBILITY REQUIREMENTS

- There is no age limit for individuals with an intellectual disability or autism. Individuals with a developmental disability with a high probability of resulting in an intellectual disability or autism are eligible from age 0 through 99
- Have a diagnosis of intellectual disability and/or autism. Eligibility criteria is defined as a diagnosis of intellectual disability that is based on the results of a standardized intellectual psychological testing, which reflects a full scale score of 70 and below or have a diagnosis of autism. Eligibility criteria is defined as a diagnosis of autism based on the results of a standardized diagnostic tool; and
- 2. Intellectual disability or autism occurred prior to age 22; and
- 3. Substantial adaptive skills deficits in 3 or more areas of major life activity: self-care, understanding and use of language, learning, mobility, self direction and/or capacity for independent living based on a standardized adaptive functioning test, and
- 4. Be recommended for an IFC level of care based on a medical evaluation
