<p align="center"><b>Attendant Care Waiver/Act 150 Program</b></p>	<ul style="list-style-type: none"> <li>• Age 18 through 59 (over age 59 conditional)</li> <li>• Meet nursing facility level of care; those who do not MAY qualify for Act 150 program</li> <li>• Requires assistance with activities of daily living due to a medically determined physical impairment which can be expected to last for a continuous period of not less than 12 months</li> <li>• Mentally alert and capable of selecting, supervising, and if needed, firing an attendant, and managing their own financial and legal affairs</li> <li>• Be found in need of a basic service</li> </ul>	<ul style="list-style-type: none"> <li>• Community Transition Services (available only through Medicaid Home and Community Based Waiver Services)</li> <li>• Financial Management Services</li> <li>• Participant-Directed Community Supports</li> <li>• Participant-Directed Goods and Services</li> <li>• Personal Assistance Services</li> <li>• Personal Emergency Response System (PES)</li> <li>• Service Coordination</li> </ul>
